The Massachusetts Department of Conservation and Recreation (DCR) permits the Charles River Watershed Association (CRWA) use of Artesani Park for its Finish Line Festival on the day of the *Run of the Charles: Boston's Premier Paddling Race*. All who use Artesani Park on the day of the *Run of the Charles* do so at the discretion, and with the permission, of the CRWA. According to the terms of the DCR permit, any organization, business or individual wishing to grill food is limited to a gas grill only and must have written permission from CRWA. In addition, the grill must be barricaded from the general public for safety reasons. These are the only conditions allowed.

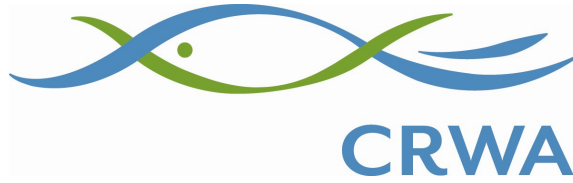

- 11. VEHICLE PARKING** – There is only one parking lot at Artesani Park, which fills up early with spectators, volunteers, vendors, paddlers, etc. There is no driving allowed on the grass unless a race official approves. Please get to the Park early to set up and then move any large vehicles, to another location if at all possible. **There is no parking on Soldiers Field Road. Parking is available in three lots east of the finish line and limited space may be available at other locations which will be announced closer to event. WE STRESS THAT CARPOOLING IS ESSENTIAL.**
- 2. LITTER** - In consideration of the environment, Charles River Watershed Association urges you to please recycle in every way you can and dispose of all trash in the trash cans provided throughout the park, or take your trash with you. All trash must be left bagged and/or taken away upon leaving.
- 3. PERSONAL CONDUCT** – You are granted permission to set up at Artesani Park with the understanding that this is an alcohol-free family-oriented event, and that conduct infringing upon neighboring tents or the rights of others is prohibited. This will be strictly enforced by Park Rangers and any violators will be asked to leave the premises immediately.
